1. A copy of the State license issued to applicant pursuant to the provisions of RSA 320 & 321 or assigned statement claiming exemption therefrom. <http://www.sos.nh.gov/h&plaw.html>
2. The appropriate license fee.
3. A certificate of current/valid insurance coverage in an amount not less than \$500,000, and will remain in effect during the term of the license.
4. At the request of the Police Chief, a certified copy of the applicant's and any and all employee's motor vehicle and criminal record from the state that they reside as well as from the State of New Hampshire.
5. A copy of the principal's and any agent's driver's license or other State issued picture identification card.
6. Food vendors must attach a copy of their sanitation inspection certification as required by RSA 143 and RSA 143-A. Food Vendors that are not required to obtain a Food license from the State must be inspected by the local Health Officer.

As the applicant for a license to perform hawking and peddling, I understand that I must attach the required paperwork as outlined in the application. By my signature, I state, under penalty of Unsworn Falsification (RSA 641:3), that the information provided is true and that I have read and understood the ordinance regulating hawking and peddling in the Town of Bristol, New Hampshire and am aware of all requirements and penalties.

An application fee must be submitted at the time of application. (If the application is submitted less than (15) fifteen days prior to the event the application fee is an additional \$25.00.) Payment must be made by bank, cashier or certified check made payable to the Town of Bristol.

Penalty:

Any person who violates any provision of this Ordinance shall be guilty of a violation and subject to a penalty in the amount of \$500.00. Such person shall be deemed to have committed a separate violation for each and every day or portion of which any violation of the Ordinance is committed, continued or permitted by such person.

License may be revoked for just cause after notice and hearing.
