# **Call to Order:**

Mr. Therriault called the meeting to order at 6:04pm.

## **Old Business**

## 01-4140: Tax Collector

Motion to move bottom line of #4140 in the amount of \$78,062 by Mr. Therriault, seconded by Mr. Waring. Mr. Coates stated Mrs. Simpson's budget has changed due to a Warrant request by Select Board for Charter Commission elections. Motion to amend line #131 Supervisors of the Checklist in the amount of \$1,807 by Mr. Therriault, seconded by Ms. Dion. This line consists of the wages of the supervisors. Motion passed by roll call vote 7-0-0. Motion to amend line #191 Ballot Clerks in the amount of \$630 by Mr. Therriault, seconded by Ms. Dion. Mrs. Simpson stated she needed three ballot clerks. Motion passed by roll call vote 7-0-0. Motion to amend line #550 Advertising in the amount of \$676 by Mr. Therriault, seconded by Mr. Waring. Motion passed by roll call vote 7-0-0. Mrs. Simpson stated that she posts the election two days in the Laconia Sun and one day in the Newfound Landing. Motion to amend line #610 Election Supplies in the amount of \$1,897 by Mr. Therriault, seconded by Mr. Regan. Motion passed by roll call vote 7-0-0. Mrs. Simpson stated that it is cheaper to buy 1,000 ballots rather than 500.

### 01-4152: Property Reappraisal

Motion to move bottom line of #4152 in the amount of \$124,211 by Mr. Therriault. Mrs. Goodwin stated that the old utility appraisal vendor's quote for a year increased. The Town found the current vendor who quoted a lower amount and a contract was signed in December 2020, locked in at \$17,500. Motion to amend line #312 Contract Services to \$36,500 by Mr. Therriault, seconded by Ms. Dion. Motion passed by roll call vote 7-0-0. Mr. Regan inquired on line #120 Admin Assistant and the change in rate of pay and hours. Mrs. Goodwin stated the job is combined with Highway and the Select Board's suggestion was to increase the rate. Motion to amend line #120 Admin Assistant in the amount of \$15,849 by Mr. Therriault, seconded by Mr. Waring. Motion passed 6-0-1. Motion to amend line #220 FICA in the amount of \$4,507 by Mr. Therriault, seconded by Mr. Caristi. Motion passed by roll call vote 6-0-1. Motion to amend line #225 Medicare in the amount of \$1,053 by Mr. Therriault, seconded by Mr. Regan. Motion passed by roll call vote 6-0-1. Motion to move the amended bottom line of #4152 Property Appraisal in the amount of \$123,604 by Mr. Therriault, seconded by Mr. Waring. Motion passed by roll call vote 6-0-1.
