### **NHDES Response to COVID-19**

The coronavirus pandemic has caused many of us to do business differently. [NHDES has set up a webpage](#) as a clearinghouse for information related to any changes in NHDES program activity. NHDES will do its best to communicate any changes directly with our program customers and stakeholders, however please check this webpage regularly, as we will update information as necessary.

### **Drought Information**

As of Thursday, June 24, over 70% of New Hampshire has been upgraded from “Abnormally Dry” (D0) to “Moderate Drought” (D1), while the northern 30% of the state continues to experience “Abnormally Dry” (D0) conditions. NHDES has advised public water systems to carefully track supplies and implement outdoor water use restrictions as needed. NHDES is advising municipalities in drought areas to consider imposing lawn watering restrictions, as authorized by RSA 41:11-d, to ensure the community is able to continue to meet essential needs as conditions worsen. ### **Free Face Coverings for Solid Waste and Recycling Industry**

SWANA is collecting orders online for cloth face coverings through July 17 on behalf of the entire U.S. solid waste and recycling industry. These face coverings will be available at no cost to companies and agencies in the industry. The Federal Emergency Management Agency (FEMA), the U.S. Department of Health and Human Services (HHS), along with other federal partners, are distributing cloth face coverings at no cost to essential critical infrastructure workers in the United States and has asked SWANA to assist in the distribution. ### **Request for Proposals for the Installation and Operation of Level 2 Electric Vehicle Supply Equipment in Concord NH - Notice of Change to Question and Response Dates and Addition of Language to Section 3.1 Regarding Payment Card Industry Data Security Standard (PCI DSS) Requirements**

NHDES and the Governor's Office of Strategic Initiatives (OSI) announced the release of a second revision to the above referenced RFP. NHDES is seeking proposals from qualified Vendors to furnish, install, maintain and operate electric vehicle supply equipment (EVSE) at a state-owned lot in downtown Concord, NH. The revision was necessary to address PCI DSS requirements that were not included in the existing RFP. In addition to the addition of PCI DSS requirements the deadline for submitting questions has been changed to June 30, 2020 and the

#### **New Funds Available! Brownfields RLF Cleanup Grants**

The NHDES Brownfields Program is making available \$400,000 for two or more Cleanup Grants and is soliciting applications from interested eligible entities. The cleanup grants will provide funding to conduct cleanup activities on properties where the redevelopment or reuse of the site is complicated by the presence or potential presence of a hazardous substance or contaminant. Individual grants will be limited to no more than \$200,000 per site. The deadline for submitting applications is August 31, 2020. #### **2020 Funding for Drinking Water Infrastructure Projects**

The New Hampshire Drinking Water and Groundwater Trust Fund Advisory Commission (Commission) has allocated up to \$30.9 million from the Drinking Water and Groundwater Trust Fund for loans and grants for the Special Projects Assistance Program, which targets drinking water infrastructure projects addressing contamination, time critical needs, economic hardship or associated with an extension of a public water system, and the Annual Drinking Water Construction Project Assistance Program (Annual Round). Special Project Assistance Program funding and special project applications can be submitted at any time and are reviewed on a case-by-case basis. The Annual Round funding applications are due on September 10. Eligible applicants and projects are defined in the [Rules for Construction Projects](#) and include engineering and/or construction for drinking water related infrastructure projects including but not limited to contamination, growth and drinking water improvements. Funding decisions for the Annual Round are anticipated to be completed by late fall. More information is available at [Link to Construction Project Information](#).
